- RENEW online with a credit card at www.deltaclippedwings.org
- Click on "RENEW MEMBERSHIP" in the QUICK LINKS section
 - Enter your email address as your USERNAME
- You are not provided a password the first time you log in, so click on "FORGOT YOUR PASSWORD" below the grey LOGIN box to create your personal password
- Before you can proceed into the site, you will be instructed to change your profile phone numbers to a (xxx) xxx-xxxx format Note: there is a space after the end parenthesis of the area code (xxx)
- If necessary, you may also make other changes to your profile, e.g., home address, email address, etc.
 - Once logged in, you can enjoy the entire site
- You will receive an email confirmation showing your dues payment and your new membership expiration date
 - Print this email from your browser for your records

MEMBERSHIP FORM: You can print/mail the form attached to this newsletter or print one from our website.

CARRYOVER DUES: If you joined/renewed after May 1, 2015, your dues have been applied to the 2015-16 membership year and your dues expiration date has been change accordingly in your profile.

EMPLOYEE NUMBER: For **NEW** member online applications, we require an employee number so Delta HR can verify IFS employment. This is to protect our member information since the public has access to part of our website. NEW members will be "activated" once we hear back from HR.

DIRECTORY PRINTING/DISTRIBUTION: The "Red Book" directory goes to print before Thanksgiving and the number ordered is based on the number of renewals received by October 31st. VENDOR INFORMATION

We are so excited about our upcoming Holiday Bazaar and wanted to give those of you who are interested in being a vendor some important information as the deadline for registering is October 23rd. Space could be a challenge as this is a new venue for us, so the sooner you register, the better chance you have not to be turned down due to us being at full capacity.

You will find a vendor registration form at the end of this newsletter; it includes additional information that is not in this article, so please be sure to read through it before you contact me as it might answer any questions you have. You may send your registration form to me by fax (770.569.9887), email (flygirlroy@yahoo.com) or snail mail (1950 Buford Dam Rd, Unit 503, Cumming, GA 30041). I will also have forms at the October 20th luncheon so you may drop off your form to me at that time as well.

The Conference Center needs our final vendor count by October 23rd due to the number of tables we need, including the fact there are other events at the same time at the Center. All that to say, it is imperative we make sure the space is blocked out for our needs.

We will be in a large ballroom with a separate lobby reserved just for us. Half of the ballroom will be the bazaar and the other half will be the dining area. There is also room in the entry lobby that will feature some of our vendors as well (e.g., charity groups and/or food vendors).

Please note, the Conference Center has a separate entrance on the right side of the driveway as you approach the Hotel front entrance. That will be your entrance to unload your items and proceed to the ballroom. The entry is covered and there will be rolling carts to help transport your items inside. Once inside you will be met by either me or a volunteer who will check you in, receive any payment due for your table(s) and take your \$50 donation for our 2016 March Fundraiser / Silent Auction.

TABLES: You will notice on the registration form I need to know what size table(s) you need, i.e., 6' or 8'. While the Conference Center has both sizes, they have to know how many of each are needed so your help in letting me know is imperative. Note: You ARE allowed to bring your own table(s); however, I need to know the exact size of the table. Emails from Sue Zino will now show that address in the "FROM" field instead of her personal address.

IMPORTANT NOTE: Do not use the dcw@memberclicks-mail.net email address to send life event news (e.g., illness, births, passings, etc.). Please continue to send those emails to Carol Ellington (caepru@bellsouth.net) and Sue Zino (sszino45@gmail.com).

- **Username:** Your username is your email address
- **Password:** You are not provided a password the first time you log in, so click on "FORGOT YOUR PASSWORD" (below the gray login box) to create your personal password
- **Phone numbers:** You will have to change the format of your phone number/s to (xxx) xxx-xxxx to complete your login process the first time. **Note:** There is a space after (xxx).

Once logged in, enjoy the **following** online "Members Only" features:

- **View** and change your personal profile

- **Add** a photo of yourself to your profile (find your favorite image in your picture gallery on your computer, crop it to a "head shot," save it to your computer, go to your profile online and follow directions to add/upload your photo)

AUTOMATED DUES RENEWAL NOTICES

- Our database is now managed through **MemberClicks**, an Atlanta data management company for small-staff organizations. As a courtesy, this NEW system will send out a **60-day, 30-day and 7-day** renewal reminder.
- **October 31 is the dues expiration date.** Renew by October 31 to be listed in the "Red Book" directory.
- **RENEW up to four years in advance.**
- For those who have paid ahead or after May 1 of this year, your **expiration year** will be "pushed forward" to the appropriate year. You will continue to receive all correspondence from DCW as we proceed with our 2015-16 dues renewal process.
- **If you prefer, PRINT/MAIL** a form (attached to the September and October newsletter ONLY or found on our website): Delta Clipped Wings, PO Box 19773, Atlanta, GA 30325-9773.

ONLINE FORMS

For all online forms you will receive an email confirmation for your records. Only credit card payments are accepted online. NOTE: DEBIT/CREDIT cards are processed as a credit card.

- NEW Membership Form: Public access ~ for our member's security, **online applications will be verified by Delta HR before we activate a NEW member.**
- RENEWAL Membership Form: Member Only access.
- EVENT Registration Form: Member Only access ~ you can register/pay for yourself and up to 5 guests ~ you will have to make meal choices to complete the process ~ you can register for the next event the day after the current month's event.

AFTER you log in, there are two ways to access the registration form:

- 1) Click on "Event Registration" in the Quick Links section
 - 2) Click on "Register for" link in the Event Section where the monthly events are listed.
