

* Mike Boyce: Over his Marine Corps career his duties took him around the world and he served as Commander of Marine Somalia. He is a parachutist and Naval aviator in both fixed and rotary winged aircraft. He is a distinguished graduate of the Naval War College and retired from the Marine Corps in 2001 with the rank of Colonel. Mike is a member of several veterans and service organizations including Marine Corps League and Kiwanis. He has a BA from University of Notre Dame and a Master's degree from Pepperdine.

** Bruce D'Agostino: During his four years with United States Air Force, Bruce attended enlisted basic training and Communications Equipment and Crypto school for his first year in the Air Force. He was assigned to Yokota AFB Japan for three years during which he served in Vietnam for four months rebuilding equipment. During that same period, he also became a combat photographer, having his works published in 1967 & 1968 by Associated Press Saigon while working with Pulitzer Prize winning photographer Horst Fass.

Bruce is currently a Life member of the Atlanta Vietnam Veterans Business Association, a Life member of the Disabled American Veterans and a member of the American Legion.

In 1987 through 1990 he was a volunteer negotiator traveling twice to Hanoi, as well as, to the United Nations numerous times with White House and State Department authorization as a civilian, volunteer negotiator for return of our MIAs, as well as seeking and securing complete withdrawal by the Vietnamese from the Cambodian war.

He currently serves as a volunteer mentor with Judge Green's Cobb County Superior Court, assisting current day veterans in their recovery and reintegration into civilian life.

The narrated cruise lasts one hour and a half. There is plenty of time to enjoy the buffet and walk around the decks of the boat as we cruise the Tennessee River. Please feel free to bring a friend; they do not have to be a DCW member. We will have the usual festivities aboard the bus ~ to and from our destination.

EMERGENCY TRAVEL FOR DELTA PEOPLE

Note: The S1A Emergency standby code provides for an elevated standby priority in the event of a life or death emergency. This code is limited to the following situations:

- ➔ Death and/or funeral of an eligible family member. Eligible family members include: spouse or domestic partner, parents and stepparents, siblings, children, grandparents, grandchildren, and in-laws (parents, stepparents, children, grandparents, grandchildren and siblings of your spouse/domestic partner).
- ➔ A funeral of an eligible family member. The S1A code is not intended for a memorial service that has been planned in advance.
- ➔ Hospitalization of a family member due to serious illness or accident with an impending threat of death. Scheduled surgery does not qualify for S1A Emergency use.
- ➔ In the event of a life crisis or extreme circumstance that warrants the S1A Emergency standby code, approval is at the discretion of the local manager.

Buddy pass riders and survivors are not eligible for emergency travel. Managers review a monthly report that lists all S1A Emergency travel taken by their employees and report any unapproved travel to the Employee Service Center.

EMERGENCY TRAVEL PROCEDURES

RETIREES

Retirees should notify the Employee Service Center (ESC) immediately of their intention to use an authorized Emergency S1A boarding priority. Please send an email to passtravel@delta.com (preferred) or 800 MY DELTA (800.693.3582). If after hours for the ESC, notification should be made as soon as possible or at the retiree's earliest convenience.

Please include the following information:

- ➔ Name of passenger
- ➔ Origin and Destination city

- Dates of travel (to and from origin and destination)
- Nature of emergency and retiree's relationship to individual that is critically ill or deceased.

ACTIVE & INACTIVE EMPLOYEES

- The employee should notify his/her manager at their earliest convenience that an emergency has occurred and obtain approval to travel using an Emergency S1A flight day.
- Emergency travel may be authorized as one way or round trip.
- When checking in at the airport or kiosk, the pass rider indicates that he is using an Emergency S1A boarding classification.
- Unapproved travel may result in a penalty of \$150 per domestic flight day and \$300 per transoceanic flight day, suspension of pass privileges and/or administrative action up to and including termination.
- Managers receive a monthly report which lists all Emergency S1A travel taken by individuals within the manager's department.
- Managers review the list and report any unapproved travel to the Employee Service Center, 951/ATG.

EMERGENCY TRAVEL ON OTHER AIRLINES

Most airlines have discontinued emergency travel and refer employees to the ZED agreements already in place. For more information on Interline pass travel, go to the OTHER AIRLINES AGREEMENT CHART. This chart can be found on DeltaNet.
