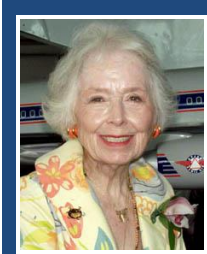

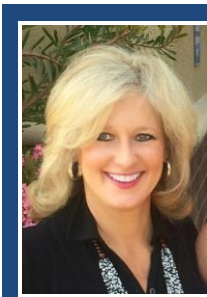

*MaryLou's first treatment was January 19th.

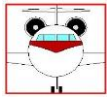
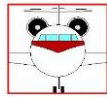

What is the 1957dcw@gmail.com email address listed for some members in the 2016-17 Red Book directory?

- First, you **MUST** be logged in to access the online donation form.
- The form can be found under the **DONATION** tab on the **HOME** page; choose **FUNDRAISER ITEM DONATION** from the dropdown menu.
- Be sure to fill in the date where it asks ... **DATE OF EVENT: MARCH 24, 2017.**
- **The online submission form deadline is FEBRUARY 24, 2017.**
- Be sure to include a description and any blackout/expiration dates.
- Once submitted, the form is sent to Sandy Chinn so she can catalogue your items.
- **TAX RECEIPT:** You, as the "member/solicitor" through the online form, will receive an email confirmation with **ALL** the necessary information for tax records.
- **PRINT THREE COPIES: ONE for your TAX RECORDS, ONE to include with your donated item and ONE to give to the business you solicited IF you want.**
