MEMBERSHIP INFORMATION

- ➔ Automated dues renewal notices are currently being sent to members with an email address on a 60-, 30- and 7-day schedule for the October 31st deadline.
- ➔ After October 31st, the "You have been bumped" notices will automatically be sent to those who have not renewed and they will no longer receive correspondence from us.

EXPIRATION DATE CLARIFICATION

Because of the date-based system we use for the dues reminders, **NEW** members who join(ed) **BEFORE** October 31st will have a 2017 expiration date on their email confirmation; however, we will correct that to 2018 or beyond if they joined for multiple years.

Members renewing for 2017-18 should see 2018 as their new expiration date on the confirmation email.

Jean fell in her apartment on August 26<sup>th</sup>. She was taken to the hospital and passed away shortly afterwards.



Jean flew from 1951-57 when she resigned to marry and begin a family. In 1978, she returned to Delta's Reservations department focusing on the "Tours to Europe" division. She resigned again in 1988.

She was very proud to be part of the famous corporate Delta culture that thrived on taking care of their employees and customers. She also loved supporting Delta Clipped Wings after getting her own wings clipped in 1957. From 1962-63 she served as DCW's vice president under Pep Green and as president from 1963-64. She also held numerous other officer positions through the years.

The following is a small portion of an article Bea Van Vliet wrote in 2007 when each month we featured one of our founders leading up to our 50<sup>th</sup> Anniversary Celebration in September 2007.

Jean's dream was to be a stewardess for Delta Air Lines, so in 1948 she came to Atlanta with two friends from Rollins College in Winter Park, FL to pursue her life-long passion. She worked for three years to save enough money (\$300) to attend Barbara Spiers Stewardess School; upon completion of the course she was hired by Delta.

Jean was quite proud of her flying status and recalled in her 2007 interview with Bea that she had met such famous notables as Claudette Colbert, Oleg Cassini and Sally Rand. "Every trip was an adventure to me! I enjoyed meeting and greeting new passengers. There was a certain elegance about flying back then. Everyone was dressed up, not stressed and very rarely upset by delays."

Christine O'Shields | AHS Development Manager shared the following info with us.



As of September 22<sup>nd</sup>, the Atlanta Humane Society had taken in over 500 animals from shelters affected by Hurricanes Harvey and Irma. These animals were shelter residents before the hurricanes and were taken into the care of AHS to make room for the influx of flood-victim animals in local Texas and Florida shelters. This process afforded the flood-victim animals the best possible chance of reunification with their families in these states.



AHS also deployed a team of disaster responders to Houston on September 4<sup>th</sup> in an effort to aid their many shelter partners and support all the animals in need. They collaborated with other members of the animal welfare community - both in and out of the metro Atlanta area - to help as many animals as possible throughout this time of disaster.

AHS has many community partnerships that are invaluable to their success and that includes the partnership with Delta Clipped Wings. On average, over 40 animals per month find their forever homes with Veterans or active-duty military members through the Pets for Vets program. Those adoptions provide the opportunity to assist even more animals and families who come to the Atlanta Humane Society to find love.

**Delta to offer enhanced pass travel on Aeroméxico**

Delta is making additional improvements to the nonrev travel program shared with its joint cooperation partner Aeroméxico.

Effective September 1, 2017, Delta employees, retirees and eligible family members will travel on the entire Aeroméxico network free of charge - only international taxes and fees will apply. This represents the elimination of the ZED low fares currently in place.

"Our partnership with Aeroméxico is great for our business and also for Delta people," said Rob Kight, S.V.P. - Human Resources. "Closer international relationships often bring about better pass options, which is a win for everyone."

When traveling on Aeroméxico, Delta employees will also be placed on a higher boarding priority for the economy cabin. This places Delta nonrevs just after Aeroméxico nonrevs but ahead of all other Aeroméxico codeshare and interline partners. Employees will continue to obtain standby tickets and list for Aeroméxico flights through

TravelNet and the myIDTravel site.

Tickets purchased prior to September 1 can be refunded on the myIDTravel website which can be accessed via TravelNet.
