- ★ **AUTOMATED RENEWAL NOTICES:** The 60-day courtesy renewal notices will go out **via email** on September 1st, the 30-day and 7-day reminders will follow, if necessary.
- ★ **EXPIRATION DATE:** If in doubt about your expiration date, check your online profile **BEFORE** you renew again!! If you have paid for multiple years, you **WILL NOT** receive an automated notice this year and do not need to renew.
- ★ **PAPER MEMBERSHIP FORM:** If you prefer, you may submit a paper form. Mail the form and check to: Delta Clipped Wings, Inc., PO Box 19773, Atlanta, GA 30325-9773. You may print a form from our website or use the one attached to the **September and October** newsletters.
- ★ **RED BOOK DIRECTORY:** To be listed and to receive the directory, renew by October 31st.
NOTE: To "Opt Out" of receiving a hard copy of the directory, check the "Red Book Opt Out" option at the bottom on the online / paper renewal form.

- ★ **NEW MEMBERS:** If you joined **AFTER** May 1st and before 31st, the expiration date will be "pushed forward" by us to the correct year.

Payment Deadline: Payment must be received by Friday, September 20th, so the count may be given to the facility. DCW is responsible for paying for that number of guests whether they attend or not and while we want to remain flexible and sensitive to personal circumstances, please understand we are not always able to make refunds once the count is finalized. Your check will be your reservation.

Check-In: Check-in begins at 10:30, please make every effort to arrive before 11:00 as the final number of attendees will be given to the kitchen at that time.

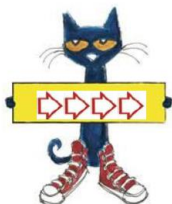

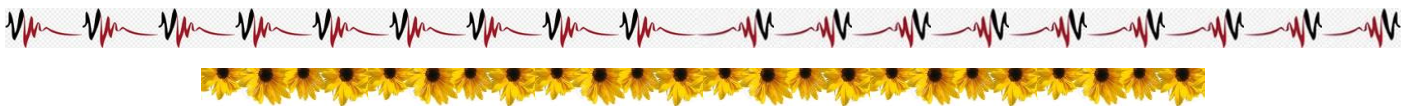



2019 MEMBERSHIP YEAR
(September 2019 through August 2020)

Delta Clipped Wings, Inc. (DCW) is a 501(c)(3) organization based in Atlanta, GA. Founded in 1957 by John Sutton, Superintendent of Passenger Service, and former stewardess, Jan Fairchild Jones, DCW has been charity based since its inception.

We are an amazing group of former and active Delta flight attendants who share a common bond through our memories and experiences while working in the In-Flight Service Department. This commonality provides a rich environment of friendship as we once again “work together” during our fundraising events in support of our charities: **CURE Childhood Cancer; Atlanta Humane Society’s Pets for Patriots and The Breast Cancer Research Foundation.**

Activities are scheduled from September through May with a three-month summer break June - August. Members receive a monthly newsletter, THE BRIEFING SHEET, and a printed membership directory unless they “opt out” and prefer to use our online directory.
